FINAL PLAT APPLICATION

SUBMITTALS

A preliminary plat application for approval of a subdivision for four (4) or more lots is made by submitting the following information to the City Clerk:

1. The completed attached form and checklist;
2. A copy of all final plat documents (see Municipal Code Title 10, Section 3-2 for specific information);
3. **A FEE** of \$50.00 per lot at the time the application is submitted plus all estimated costs incurred by the City Engineer, City Attorney and other City Officials including any costs of processing the application payable to the City of Hayden Lake.

DEADLINE FOR SUBMITTALS

The completed form and plat documents must be submitted to the City Clerk not later than sixty (60) days prior to the date of a regular City Council meeting where consideration of the final plat can be set. The completed application shall be deemed accepted for the sixty (60) day processing period as of the date when all maps are and information have been filed, checked and accepted as complete by the City Engineer, as noted below. **This item will not be set for Council consideration until the application is complete and is accepted.**
