SHORT PLAT APPLICATION

(three or fewer lots)

SUBMITTALS

A short plat application for three or fewer lots is made by submitting the following information to the City Clerk:

1. The completed attached form and checklist;
2. Copy of all short plat documents (see Subdivision Ordinance for specific information);
3. One reduced scale map in an 8 2" x 11" format;
4. A fee of \$100 per lot at the time the application is submitted plus the cost of the City Engineer, the cost of publication and other costs of processing the same payable to the City of Hayden Lake.

DEADLINE FOR SUBMITTALS

The completed form and plat documents must be submitted to the City Clerk not later than sixty (60) days prior to the date of a regular City Council meeting where consideration of the plat can be set. The completed application shall be deemed accepted for the sixty (60) day processing period as of the date when all maps and information have been filed, checked and accepted as complete by the City Engineer, as noted below. **This item will not be set for Council consideration until the application is complete and accepted.**
